C. Length of Program: Two and one half weeks with 117.25 residential hours.

D. Payment Information

Tuition Amount

1. Tuition for the program is \$3499 that includes an application fee of \$100 and book costs of \$200.
2. Additional tuition costs apply for prerequisite 45 hour Anatomy & Physiology course, CPR course and required reference books for your practice. See catalog for list of reference works.
3. Total tuition amount including prerequisite costs is approximately \$3600 to \$4100 depending on the A&P course and prices of other required texts.

Other costs

1. Lodging is approximately \$99 per night or per week depending on place.
2. Professional organization testing and dues of \$225, National Certification testing of \$300, professional liability insurance \$90-\$400 and other fees for business licenses, transaction privilege tax license and liability insurance may apply and are approximate when initiating a practice.

Payment Schedule

1. \$100 is due with the Application Form.
2. The remaining \$3399 is submitted with the enrollment form.
3. Enrollment form with payment is due 30 days before Course Date.

Late Charges and Cost of Collection

An additional \$20 fee will be charged on payments received by the Intestinal Health Institute any day later than the due date. The IHI shall be entitled to recover reasonable attorney's fees and costs of collection should legal action be necessary to recover monies owed to the IHI by the applicant.

E. Refund Policy

In accordance with State law, if an applicant is not accepted having made an initial payment, all monies will be refunded.

Three-Day Cancellation: An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday and federal or state holidays) of signing an enrollment agreement is entitled to a refund of all monies paid.

If a student cancels **after three business days** of signing the enrollment agreement, all monies will be refunded except for the \$100 registration fee and \$175 book fee.

Other tuition refunds are determined as follows:

1. Before the beginning of classes, the student is entitled to a refund of 100% of the tuition less the registration fee of \$100 and book fee of \$175.
2. After the commencement of classes, the tuition refund amount shall be determined as follows:

% of the clock hours attempted:	Tuition Refund amount:
10% or less	At least a 90%
More than 10% and less than or equal to 20%	At least a 80%
More than 20% and less than or equal to 30%	At least a 70%
More than 30% and less than or equal to 40%	At least a 60%
More than 40% and less than or equal to 50%	At least a 50%
More than 50%	No Refund is required

If a program on a particular start date is cancelled or changed, IHI offers a full refund or the option of choosing another program start date within a year. The IHI is not responsible for airline tickets, other tickets or payments, or any similar penalties that the student may incur because of any program date cancellation or change.

Students must notify the Director of IHI in writing or by certified mail if they need to cancel out of a Program. The amount of the refund is determined by the expected last date of attendance and the notice must be signed and dated by the student.

Students may transfer their acceptance from one Program date to another free of charge **within three business days** of signing the enrollment agreement. A transfer fee of \$50 is charged for a transfer after three business days.

Book costs are non-refundable **after three business days**.

The costs associated with **prerequisites** are separate from those of the tuition. The costs of prerequisites are not to be part of the refund.

The Institute regrets that it cannot make exceptions to this Refund Policy for any reason including personal emergency. However, the student has the option to take the Program within a year with a transfer fee of \$50 and a re-registration fee of \$100.

Refunds are mailed within 30 days of the date of notification.

F. Job Placement Disclaimer

This institution does not guarantee job placement to graduates upon program/course completion or upon graduation.

G. Holder in Due Course Statement

“Any holder of this consumer credit contract is subject to all claims and defenses which the debtor could assert against the seller of goods or services obtained pursuant hereto or with the proceeds hereof. Recovery hereunder by the debtor shall not exceed amounts paid by the debtor. (FTC Rule effective 5-14-76.)”

H. Procedure for Withdrawal: Withdrawal requests must be written and dated.

I. Dismissal Policy: Failure to satisfactorily complete the academic or internship aspects of the training, non-payment of tuition, unethical behavior, or failure to comply with the rules as stated in the program catalog and code of ethics will result in dismissal from the school. In which event, the provisions of Paragraph (E) shall govern the Applicant's entitlement to refund of tuition.

J. Professional Standards: Certification standards vary greatly in different jurisdictions. Our program meets or exceeds the standards set forth by the International Association for Colon Hydrotherapy, the largest professional organization overseeing standards in the field of Colon Hydrotherapy.

K. Notice to Applicant: To fulfill the Intestinal Health Institute's intention of providing high-quality education, the school may from time to time, modify program content or schedule in order to improve curriculum and/or reflect changes in national standards.
